Resumen e introducción

Investigación y recursos: el

- gobernador Phil Murphy promulgó la ley A-3904 (PL2020, c.27 o Capítulo 27) en abril de 2020 que requiere que cada distrito escolar de New Jersey presente anualmente un Programa de Instrucción Virtual o Remota de Emergencia.
- El Distrito Escolar de la Ciudad de Neptune sigue cuidadosamente todos los requisitos de la Oficina del Gobernador, el Departamento de Educación de Nueva Jersey, el Departamento de Salud de Nueva Jersey y la Oficina de Educación del Condado de Monmouth.

Durante los años escolares 2020-2021 y 2021-2022, el distrito escolar de la ciudad de Neptune, un distrito escolar de PreK-8, se enorgulleció de permanecer abierto cinco días a la semana con solo cuatro pivotes para la instrucción remota virtual completa. Esto se logró siguiendo todos los protocolos de salud y seguridad recomendados, trabajando en un horario comprimido de ocho períodos al día y eventualmente regresando a un horario completo de ocho períodos al día, y enseñando a estudiantes presenciales y remotos sincrónicamente en tiempo real al mismo tiempo cuando se les permitía hazlo Por lo tanto, durante los cuatro pivotes a la instrucción remota virtual completa, el mismo horario se utilizó con éxito con los estudiantes en los grados PreK - 1 utilizando tabletas Android uno a uno y estudiantes en los grados 2 - 8 utilizando Chromebooks uno a uno para acceder a Google Classroom.

En resumen, el Programa de Instrucción Virtual o Remota de Emergencia 2022-2023 del distrito escolar será prácticamente el mismo programa exitoso utilizado durante los cuatro pivotes a virtual remoto en los años escolares 2020-2021 y 2021-2022. El programa de este año escolar sí incluye la adición del especial de medios de la biblioteca y el programa Right at School After Care.

Programa educativo

Toda la instrucción será sincrónica en tiempo real para mantener la interacción entre maestro y estudiante.

Los períodos 1 a 8 incluyen las cuatro áreas de materias básicas de artes del lenguaje inglés (ELA), matemáticas, ciencias, estudios sociales, una de cinco materias especiales (arte/STEAM, medios de biblioteca, música, educación física, español) y recreo. 2:15 - 3:00 p. m. continúa la instrucción remota virtual para enriquecimiento, recuperación y/u otros programas de instrucción (p. ej., dotados y talentosos, salud, etc.).

El período 1 todos los lunes está bloqueado para el programa de aprendizaje socioemocional (SEL) del distrito escolar, Leader in Me, para cada estudiante y miembro del personal del distrito escolar.

Evaluación del programa educativo

El plan para evaluar el aprendizaje y la comprensión de los estudiantes no cambiará durante los períodos de instrucción remota virtual. Por lo tanto, seguirá incluyendo las siguientes evaluaciones:

Acceso a la tecnología y plataforma educativa

Tras el regreso de los programas deportivos y tres temporadas deportivas en el año escolar 2021-2022, todos los programas extracurriculares se ejecutarán en el año escolar 2022-2023 con un regreso completo a la Liga Atlética del Condado de Monmouth (MCAL):

El distrito escolar también mantiene un sólido programa de oferta de Horario B que incluye, entre otros, actividades de enriquecimiento como club de arte, banda, coro y anuario.

Programa de cuidado

después de la pérdida del programa después de clases contratado por el distrito escolar al comienzo de la pandemia, el distrito escolar ha abierto el programa Right at School para cuidado después del año escolar 2022-2023.

Desayuno y almuerzo

Muchos de los estudiantes del distrito escolar están en el programa de desayuno y almuerzo gratis oa precio reducido. El proveedor de servicio de alimentos contratado por el distrito escolar, Maschio's, coordina un día de recogida cada semana en la cafetería del distrito escolar cuando los padres/tutores recogen el suministro de desayunos y almuerzos para una semana.

Plan de instalaciones

Desde el comienzo de la pandemia y el primer plan de regreso seguro, el distrito escolar estableció y mantiene un programa riguroso de limpieza y desinfección de todos los salones del distrito escolar todos los días. De hecho, el plan de instalaciones contribuyó en gran medida a que el distrito escolar permaneciera abierto cinco días a la semana durante la pandemia, ya que ayudó a controlar el contagio hasta el punto en que el distrito escolar contuvo el COVID-19 sin brotes más allá del nivel de un solo salón de clases.

Lugares de trabajo

En períodos de instrucción remota virtual, los empleados de 12 meses, incluida la administración, el personal de oficina, incluida la enfermera escolar, los conserjes y los empleados del servicio de alimentos, trabajan en el distrito escolar según el rastreo de contactos y la cuarentena. Los maestros y paraprofesionales, según el seguimiento del contrato y la cuarentena, pueden trabajar en el distrito escolar o desde casa. Con el tiempo, ha aumentado la mayoría de los maestros y auxiliares docentes que eligen trabajar en el distrito escolar.

Local Educational Agency Guidance for Chapter 27 Emergency Virtual or Remote Instruction Programs for the 2022-2023 School Year

The New Jersey Department of Education (Department) remains at the ready to assist every local educational agency (LEA) in returning to full-time, in-person instruction for school year (SY) 2022-2023. This includes providing LEAs with guidance in the event of declared emergencies resulting in a district-wide closure. The Department appreciates the challenges that LEAs had to overcome during the 2021-2022 SY as LEAs faced a myriad of decisions affecting both the safety of their students and staff as well as the instructional experience. The Department is encouraging LEAs to reflect upon their experiences with virtual and remote instruction when planning for the 2022-2023 SY.

In April 2020, Governor Murphy issued an executive order that became P.L.2020, c.27. This law provides for the continuity of instruction in the event of a public-health related district closure so that LEAs can utilize virtual or remote instruction to satisfy the 180-day requirement pursuant to N.J.S.A. 18A:7F-9. In order to provide transparency and ensure that New Jersey students continue to receive high quality, standards-based instruction, each school district, charter school, renaissance school project and Approved Private School for Students with Disabilities (APSSDs) must annually submit its proposed program for virtual or remote instruction (Plan) to the New Jersey Commissioner of Education. This plan would be implemented during an LEA closure lasting more than three consecutive school days due to a declared state of emergency, declared public health emergency, or a directive by the appropriate health agency or officer to institute a public health-related closure. A chief school administrator or lead person must consult with the board of education or board of trustees, if practicable, prior to implementing the LEA's plan of virtual or remote instruction. A day of virtual or remote instruction, if instituted under a plan approved by the New Jersey Commissioner of Education, is considered the equivalent of a full day of school attendance for the purposes of meeting State and local graduation requirements, awarding of course credit, and other such matters as determined by the New Jersey Commissioner of Education.

LEAs must include the statutory and regulatory requirements listed in the "LEA Guidance for Chapter 27 Emergency Virtual or Remote Instruction Programs for the 2022-2023 SY," in plans for virtual or remote instruction for the 2022-2023 school year. The 2022-2023 SY plans must be approved by the board of education of board of trustees (board) of each LEA and approved by the respective County Office of Education before being posted predominately on the LEA's website. The board-approved plan and checklist are due to the respective County Office of Education no later than September 30, 2022. In the event that the LEA is directed by a public health agency or officer to provide virtual or remote instruction before garnering County Office of Education approval of the Plan, the approval date will be retroactive. Questions should be directed to the County Office of Education.



Local Education Agency Guidance for Virtual or Remote Instruction Plan Attestation for the 2022-2023 SY

The New Jersey Department of Education (Department) is providing the following guidance pursuant to *N.J.S.A.* 18A:7F-9(c) and *N.J.A.C.* 6A:32-13.1 and 13.2, to assist LEAs in the development of their 2022-2023 virtual or remote instruction plans. The Department encourages LEAs to reflect on the previous school year to enhance elements of the prior year's plan to provide the most substantive education, and including, but not limited to, related services, for all students in the event of an LEA closure.

For each of the areas below, the chief school administrator or lead person will either mark "yes," confirming that the information is in the Plan and list the corresponding Plan page number, or mark "no" if the information is not contained in the Plan. The chief school administrator or lead person is expected to provide an explanation to the County Office of Education for all areas marked "no."

By September 30, 2022, the chief school administrator or lead person must submit a board-approved LEA Guidance for Virtual or Remote Instruction Plan for 2022-2023 SY along with this form to their county office of education. At the time of submission to the county office of education, the plan must be posted on the LEA's website. Plans will be reviewed in each county office of education on a rolling basis with an electronic response communicated within two business days of receipt.

The digital divide in the school district has been conquered with one to one Android tablets in grades PreK-1, one to one Chromebooks in grades 2-8, and providing in home Internet access to parents/guardians who cannot afford to provide it. (Pages 2, 3)
