The chief school administrator or lead person is expected to provide an explanation to the County Office of Education for all areas marked "no."

At the time of submission to the county office of education, the plan must be posted on the LEA's website. In the event that a school facility in your Local Education Agency (LEA) must close due to a declared state of emergency, declared public health emergency, or a directive by the appropriate health agency or officer to institute a public health-related closure, you may use virtual or remote instruction to satisfy the 180-day requirement if the closure is for more than three (3) consecutive days.

You must post the approved plan on your LEA website. If revisions are made to this plan, please resubmit it to this office accompanied by the board approval and a new signed and dated checklist, which can be found at: <u>Guidance and Checklist: Virtual or Remote Instruction Programs</u>
